Whilst the SDA Reserves the right to avail itself of the opportunities available on Social Networking and Social Media services such as Facebook, Twitter and others as deemed appropriate it hereby issues the following Disclaimer

- a) Any content, views, opinions and/or responses to questions uploaded, expressed or submitted by the creators, sponsors, advertisers or users of social media services and other public forums as utilised by the SDA, other than the content provided by the SDA, are solely the views, opinions and responsibility of the person submitting them and do not necessarily reflect the opinions of the SDA.
- b) The SDA is not responsible for content that third parties publish post, upload, distribute, disseminate or otherwise transmit via social media services.
- c) Whilst the SDA will endeavor to maintain the currency and accuracy of information published via its own social media services, the SDA does not warrant the accuracy, completeness or usefulness of the information available on its social media channels.
- d) Where provided, the SDA acts only as a passive conduit for the online distribution and publication of user-submitted material, content and/or links and expressly does not endorse any user-submitted material, content and/or links or assume any liability for any actions of participating users.

- b) The authors of such postings may be deemed to have brought the good name of the SDA into disrepute and may therefore, at the discretion of the SDA Disciplinary Officer face disciplinary proceedings as laid down in SDA Code of Practice – DISCIPLINE

8. 00 NON-ASSOCIATED SOCIAL MEDIA PLATFORM POSTINGS
